## WINYAH BAY HERITAGE FESTIVAL 2011 EXHIBITOR CONTRACT

Winyah Bay Heritage Festival is a juried show. Exhibitor has submitted an application for participation in the Winyah Bay Heritage Festival and the Exhibitor has agreed its exhibit will not deviate from the description on its application attached hereto without prior written consent of the Winyah Bay Heritage Festival Committee, hereafter known as WBHF.

**Application submission is no guarantee of acceptance.**

1. Exhibitor registration and setup is Friday, January 14th, from 11:00 until 4:00.
2. WBHF will provide security from 4pm on Friday through 5pm Sunday. All exhibits will be removed by 7:00pm Sunday.
3. The \$100.00 entry fee is for a 10x10 space, which includes one 8 foot table with cover and two folding chairs.
4. Show hours are 10am to 5pm Saturday, January 15th, and 10am to 4pm on Sunday, January 16th. Booths will not be broken down before 4pm on Sunday, January 16th.
5. No exhibit will extend beyond the space boundaries assigned.
6. Non-exhibitor solicitation is strictly prohibited.
7. No fundraising activities will be allowed in individual's booth or any part of exhibition space without written consent by committee chair.
8. WBHF reserves the right to prohibit any exhibit, exhibitor or proposed exhibit which, in WBHF's opinion, is not suitable for this event.
9. Payment for booth space must be made in full with application form. **Application submission is no guarantee of acceptance.**
10. **Cancellation Policy:** Prior to October 1, 2010, a \$25 per booth cancellation fee will apply. After October 1, 2010 the fee will not be returned.
11. In the event of fire, strikes, rioting, civil disorders or other circumstances making it impossible to operate the WBHF, this contract shall become void at the sole discretion of WBHF.
12. Exhibitor agrees to indemnify and hold WBHF harmless for any claim or liabilities of property damage or bodily injuries, including death resulting from, sustained or alleged to be sustained by any person or persons, whether they be members of the public visiting the show, committee members or volunteers for the festival or other exhibitors, resulting from the negligence of the exhibitor, its agents, employees or persons performing services, or resulting from any equipment, machinery or items displayed by the exhibitor.

13. The exhibitor expressly releases and waives any and all claims against WBHF, its agents, officers, directors or members in consideration of the mutual agreement of the parties and the opportunity of the exhibitor to exhibit at the show herein referenced.
14. This contract is not accepted without written consent of WBHF.
15. This contract contains all agreements of the parties and may only be amended in writing by a separate document duly executed and signed by both parties.

I acknowledge I have read, understand and will abide by the rules and regulations of this agreement. I understand a space is reserved only by acceptance of the Winyah Bay Heritage Festival and with full payment along with this signed contract.
